The Naina Devi Temple Is Situated On The Northern Shore Of Naini Lake. On One Side Of The Lake Lies The Mall Road, Now Called Govind Ballabh Pant Marg. There Are Many Hotels, Restaurants, Travel Agencies, Shops And Banks Here. This Road Is A Center Of Attraction For All Tourists.

Mall Road Is The Main Road Connecting Mallital And Tallital. Thandi Road Is On The Other Side Of The Lake. This Road Is Not As Busy As Mall Road. There Is Also The Pashan Devi Temple Here. Vehicles Are Prohibited On Thandi Road.

Sightseen For the Day

- Snow View, Mountaintop scenic spot featuring a ropeway to panoramic vistas of snow-capped Himalayan peaks.
- Eco Cave Park, Garden park with shade trees, multiple caves for exploring & a mechanical bull ride.
- Tiffin Top, Scenic mountaintop locale & picnic spot offering horseback rides & views over the Nainital area.
- G B Pant High Altitude Zoo, Carved on a steep hillside, this zoo is home to a small assortment of mammals & Himalayan birds.
- Nainital Lake, Lake surrounded by hills, offering boating facilities, street-food vendors & mountain views.
- Sankat Mochan Mandir, Built in 1950, this hillside Hindu temple dedicated to Lord Hanuman offers sunrise & sunset views.
- Tibetan & Bhotia Market, Located near the Mall Road, this market is known for its woolen clothes, handicrafts, and traditional garments. It's a great place to find warm clothing, especially during the winter months.
- Bhimtal Lake, 47.8-hectare lake with a masonry dam built in 1883, home to waterfowl, wildlife & many fish species.

Claiming your credit

TCS can be fully adjusted against the income tax payable on any other income such as interest, rent, capital gains, etc.

Claim refund

In case there is no income tax payable, you can claim the refund of TCS amount at the time of filing your IT return.
